Make the Right Call

Does the warmer weather have you thinking about your next outdoor project? Let's make sure you make the right call! Before fixing the fence or planting that tree, place a one call with your local One Call service.

If your construction or home improvement project is within 30 m of the Trans Mountain pipeline, we will be notified through One Call and will be able to assist you with the pipeline safety requirements, so your project is conducted safely and in compliance with the Trans Mountain right-of-way agreement.

Not only is it a regulatory requirement to obtain a pipeline company's written consent for proposed improvements near the pipeline, it is also a condition of our right-of-way agreement registered on your property title. This consent is provided to you in the form of a permit, which can be obtained by placing a One Call, at no cost to you. After you place the One Call, a Trans Mountain Inspector will help you identify activities that would be permitted on the rightof-way and those that would be considered encroachments.

What is an encroachment?

An unauthorized encroachment is an unpermitted intrusion of a structure, part of a structure or land use into the right-of-way area. Some common examples of potential encroachments that are not permitted on the right-of-way are sheds, concrete patios, pools, hot tubs, decks, ponds, overhangs and other structures.

What if you start your project without placing a One Call?

You'll receive a visit from one of our Pipeline Protection Inspectors – they'll ask you to stop work while they locate the pipeline and take some measurements. Your plans to fix the fence or plant the tree may have to wait until you receive a written permit from Trans Mountain.

Placing a One Call with your local One Call service three working days before digging near a federally regulated pipeline is the law, but more importantly, it prevents accidental pipe damage and keeps you and everyone around you safe.

Plan, Prepare, Practice: Emergency Exercises

Last year, we completed more than 20 emergency exercises, allowing responders – including first responders from the communities where we operate – to practice deployment procedures under a variety of environmental conditions all along our pipeline right-of-way.

A full-scale exercise in Edmonton, Alberta, included more than 150 employees, external participants, and observers. Wildfire training sessions held in advance of wildfire season offered participants an opportunity to review and practice defensive firefighting strategies designed to protect our facilities from approaching wildfires. Throughout the year, in all conditions and locations, we practiced our response plans for the rare event of an oil spill.

We are legally required to have an Emergency Management Program that anticipates, prevents, manages, and mitigates emergencies. That's why all our employees and contractors receive the training necessary to protect themselves, the public, and the environment in the rare event of an emergency.
