

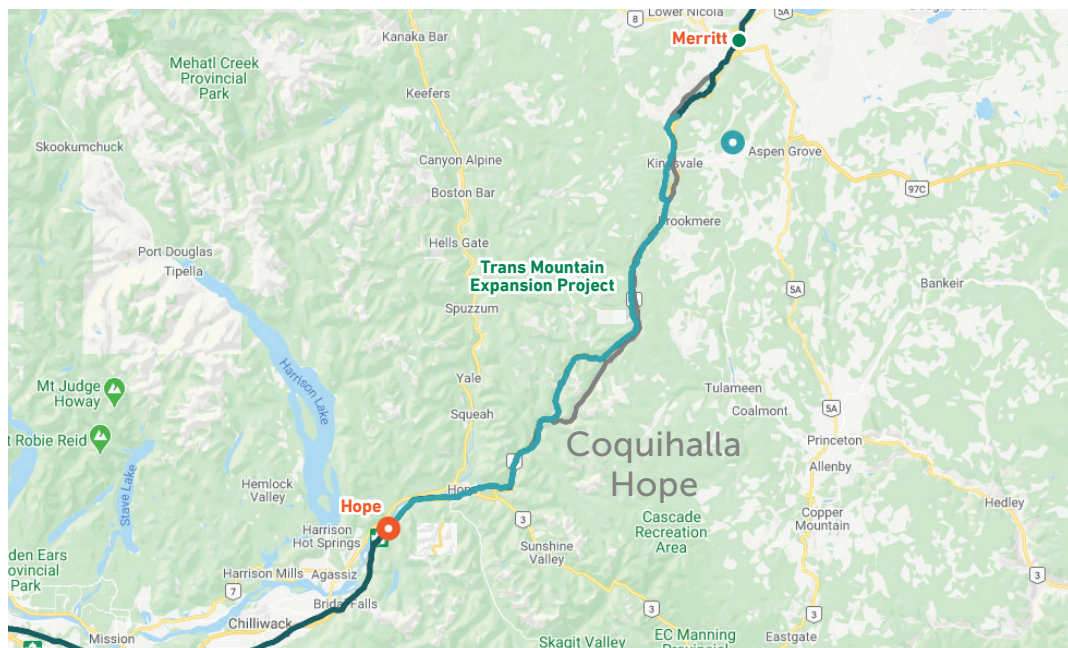
Construction activity related to the Trans Mountain Expansion Project is underway in your region.

### Anonymous complaint regarding unnamed worker allegedly with alcohol in vehicle

While the call was anonymous and the worker's identity unknown, all contractors are required to follow Trans Mountain drug and alcohol policy, and there is a zero tolerance for use of drugs and alcohol in the workplace. Fit for duty drug and alcohol testing may be applied to workers if deemed necessary.

Trans Mountain will continue to address traffic-related concerns. Contractors have a Traffic Management Plan focusing on public protection measures, access roads/routes to the construction site and Traffic Control Plans for each work zone. Trans Mountain follows up with the contractor to ensure traffic-related requirements are being met.

### Culturally modified trees observed in log deck.

Trans Mountain follows the Traditional Land Use Sites Discovery Contingency Plan in the Environmental Protection Plan in the event that a previously unidentified traditional use site is found during construction. Resources were flagged for assessment and potentially affected Indigenous groups were notified and engaged. As a result, the trees were delivered to a local Indigenous group.
