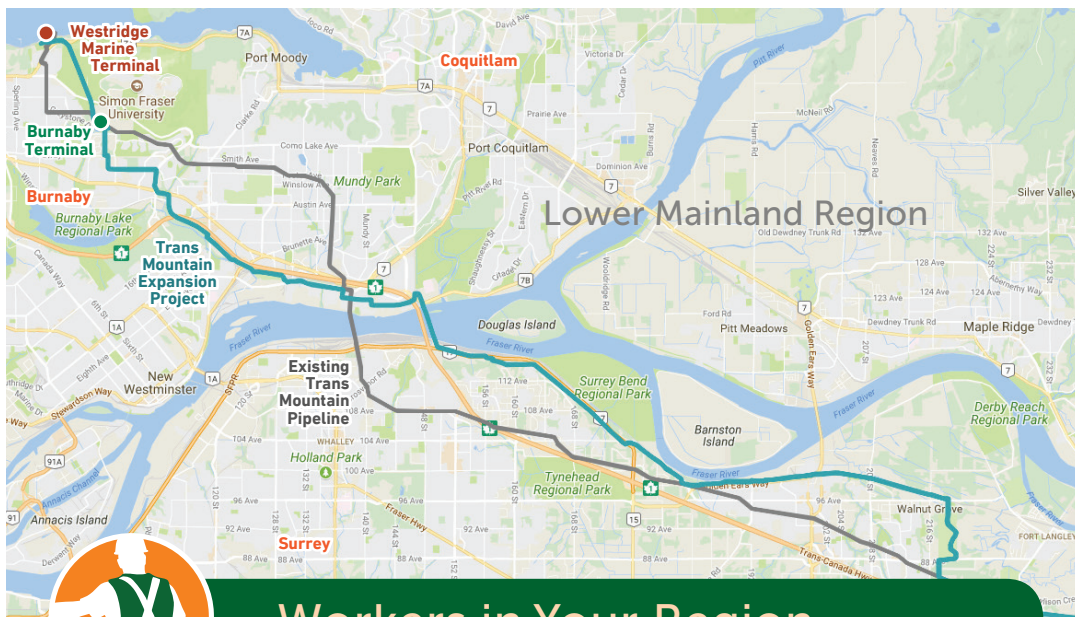


This report reflects the August 30, 2018 Federal Court of Appeal Decision cancelling the Order in Council, which had approved a Certificate of Public Convenience and Necessity related to the Trans Mountain Expansion Project. Projections* include workers required to suspend construction-related activities on the Project in a safe and orderly manner.

Trans Mountain is monitoring the impact of construction on pipeline communities through a series of indicators identified in the Socio-Economic Effects Monitoring Plan. Noise levels at the WMT construction site are monitored continuously. Trans Mountain is following approved pile installation methods as outlined in the WMT Environmental Protection Plan. These installation methods reduce the intensity of noise and vibration emitted.
